I am grateful indeed for your support and care for my family during my crisis and since our return. I am not who I was, I am weaker in many ways, life has new challenges, but I am cognizant of the grace that I have received, the grace I continue to receive.

Everything we have has been gifted to us by God. We have been blessed beyond measure by the fathers and mothers that founded these churches. We have been sustained and graced by the community around us now. God has been faithful and the community of the parish has kept the faith. Now, we are well set up to do the work of the kingdom in this time. There will be fears and there will be struggles. There will be crises within and without. But it is not a time for fear or for anxiety. It is not a time for retrenchment or undue caution. We have been gifted, and graced, and set free to do the work of God in this place. We have been gifted, and graced, and set free to deliver the church to our neighbors and to our children's children. And God, who has so gifted, and graced and freed us, promises to be with us always, to the end of the age.

Be strong! Be of good cheer! The King of Love has claimed you and will sustain you.

# IV. Pastor's Report

Pastor Dwight discussed how Peace Church is in great shape. The mortgage is down, building is in good shape, and demographics are good. There is no reason Peace cannot prosper in 2023.

# V. Committee & Auxiliary Report

Endowment Fund: A motion was made by Lori Carlson, seconded by Sandra Lynne Schmutzler to approve the Peace Lutheran Church Endowment Fund disbursement of gifts for 2022 in the amount of \$1800.

Details of the gifts given are listed on page 19 of the 2022 annual report. Motion carried.

A motion was made by Lori Carlson, seconded by Mark Schmutzler to approve the 2022 Treasurer's report as presented. Motion carried. Details of the Budget Report are listed on page 27. A motion to accept this report was made by Jerry Carlson, seconded by Kenny Voss. Motion carried.

# VIII. Old business

- -The generator is in. Peace is a community safe place now. Members thought it would be a good idea to form an emergency plan committee.
- -Beams are sealed and finished.

-The church received donated padded chairs for the sanctuary from All Saints Church in Oshkosh. The current pews have a lot of cracks and are very fragile. They will need to be replaced soon, so this was very beneficial for the Peace Church.

## IX. New Business

- -Peace has a few sink holes in the parking lot.
- -The flat roof is failing. It had a 25-year warranty (which has past) and it has been fixed several times. It is approximately \$65,000 to replace with another rubber membrane roof. A few years ago, Peace got an estimate for the roof to be pitched and have a metal roof put on. It was estimated at \$88,000. Pastor Dwight is currently getting a structural engineer to see if the walls can hold the pitch and roof. -Carl Bohman wanted members to know about the cemetery. There is a relationship of Peace church to the cemetery. Cemetery does not currently have a lot of money. Peace may have to take over at some point.
- -Members discussed forming a committee to go over all the baptized members of Peace. Currently Peace is 66% and Nelsonville is 34%.
- X. Adjounment A motion was made by Kenny Voss, seconded by Lori Carlson to adjourn at 10:12 am.

# **Abbreviated Summaries of Service to Peace Congregation**

**Lay Ministry:** Lay Visitation Communion Distribution for shut ins coordinated by leaders of Peace and Nelsonville was conducted May - November with great commitment and success.

# Peace Lutheran Church 2023 Endowment Fund Committee Report

Please refer to the accompanied Endowment Fund financial report for details on contributions, gifts that were made, and fund performance.

Thank you to all who made contributions to the endowment fund this year. Please consider the Peace Endowment Fund as you make annual charitable contributions and memorial gifts for loved ones, and in your estate planning.

This year, the endowment team, using our bylaw distribution guidelines, has determined that \$1800 of the fund balance earned income will be allocated for disbursement and be brought to the congregation at the annual meeting for congregational approval. The Endowment Resolution calls for the following formula to be used for disbursement:

<u>10-30%</u> for world-wide, national, or regional missions or charities promoted by the ELCA, including, but not limited to, grants for new congregation development, global mission, ecumenism, evangelism, social ministries, or disaster response.

<u>10-30%</u> for local mission or outreach projects including, but not limited to, social service agencies, agencies to which this Congregation relates, or to local programs and ministries.

<u>5-30%</u> to be used to support leadership training and Christian learning opportunities within our Congregation, including, but not limited to, support for professional leadership, special programs designed for leadership and growth, or for the development of a special ministry of the Congregation.

<u>20-40%</u> to be used by the congregation for any constitutionally and legally allowed purpose recommended by the Team and approved by the congregation, including, but not limited to, capital improvement, debt reduction, general maintenance, or the general fund.

# Young Blessings Preschool 2023 Annual Report

It was another busy year for Young Blessings!

We have 33 students, ages 3, 4, and 5, currently enrolled in our program. We are open from 7:15AM to 5:00PM Monday through Friday. Preschool class is held from 8:00 to noon every day and child care is provided for the rest of the day. The number of families using the full day care option increased significantly this year.

We saw our numbers grow for the summer compared to last year and continue to hear from families that they are grateful we remain open during the summer months.

This year we received a small grant from the state to make our space more inclusive. We decided to purchase sound absorbing ceiling tiles to help reduce the echo we had been experiencing when the carpet was removed in 2019. While we were only able to purchase enough this year for part of the area, it has made our space quieter, and the children are better able to focus. We will purchase the remaining tiles needed to finish the entire space in the coming year.

Cory Kearney is in her 18<sup>th</sup> year as head teacher and Barb Ramlow is in her 13<sup>th</sup> year as director. We have 4 teacher assistants: Kassie Tessman and Helena Hartzheim are starting their 2<sup>nd</sup> year with us; Madison Juarez joined us this summer and Brooke Zietlow has been with us 3 years and works as her college schedule allows. We are very thankful to be fully staffed when so many childcare centers are struggling with staffing and funding.

Young Blessings continues to receive grants from the state through the Child Care Counts: Stabilization Payment Program. The grant program was renewed by the governor and is slated to remain until 2025. Grant amounts have been significantly reduced compared to earlier funding. The smaller disbursements will help the preschool with the ever-increasing costs of supplies and wages. It also enables us to keep our program open and affordable for families.

We continue to not use the funds from our Peace Lutheran Church budget line even though we have seen an increase in our expenses and reduction in grant monies.

Our two annual fundraisers were successful again this year: Seroogy's candy bars and coffee in March, and Little Caesar's pizza kits in October. They are definitely favorites!

We partnered with the Children's Special Needs and Foster Care programs of Portage County this fall for our Giving Tree project. Our preschool families were very generous with donations of items needed for both of these programs that help children in the county.

We are very grateful for the continued support of the congregation and local community.

# Peace Lutheran Church 2023 Treasurer's Report

Greetings from the desk of the Treasurer

The year 2023 has been one of unimaginable blessings for our congregation. We have been able to resolve so many of our financial issues – it's truly unbelievable.

Due to the generosity of Florence Wetzel, who remembered the church in her estate planning, and with the help of special gifts from various members and groups, we were able to catch up on the maintenance of the beams and the roof, fix the catastrophic failure of the flat roof, AND pay off our mortgage. When I took over as treasurer in spring 2022, I would have been pleased if we could have checked even one of those projects off our To Do list. But all three? It was unthinkable. What a miracle!

Some of our special projects and funds also received generous donations, including TRACK, the Do Group, Bible Camp, and especially the Oak Grove Cemetery, which doubled its funds in just a few months. These funds came from many church members donating what they could to the categories that mean something to them.

In short, the last year has seen practically every one of our Designated Fund balances grow. We have even started to build up our Building Initiative fund, which will be used when we need to make our next round of maintenance and repairs as they occur – hopefully without having to go into debt again.

Peace Lutheran Church has been truly blessed, and our community truly is something very special.

When I think of all the churches in the country that have suffered and closed over the last few years, it would be easy to think that they suffered from financial issues. But I think the true problem was apathy. Luckily, our congregation does not suffer from a lack of caring.

To say our Matching Funds Drive was a success would be an understatement. And other than a few large donations – and the generous match, of course – it was really funded by members making modest donations that added up, almost overcoming the shortfall of the General fund that occurred over the last year as we focused on repairs, maintenance, and debt reduction.

I hope you take a look at the General and Building Fund Principal Contributions report (or what I call the Offering Totals report) for 2023. Currently our weekly offerings have not been able to cover the monthly costs of running Peace Lutheran Church. We are close, but we are not quite there. The report shows the last 7 years of monthly giving, and our weekly average had been holding steady until last year. But with a renewed commitment to supporting our church, I know we could bring these numbers up and make sure we have enough to cover those monthly costs that allow us to spread our gifts throughout the community that has supported us.

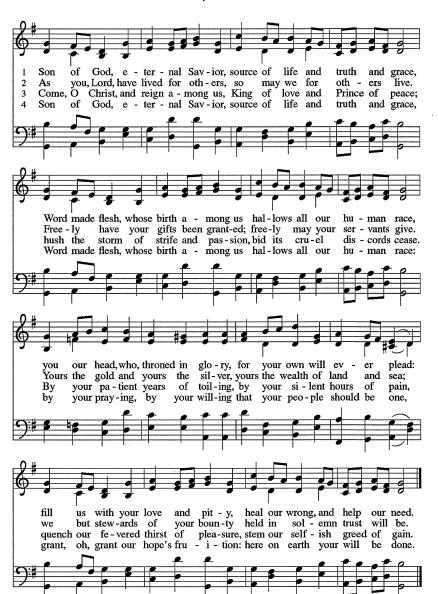
